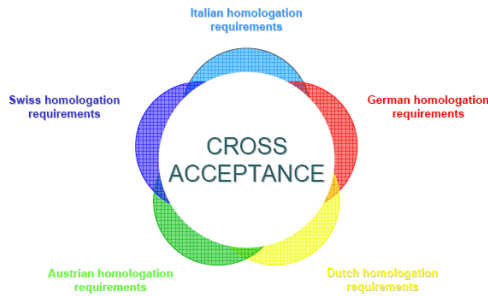

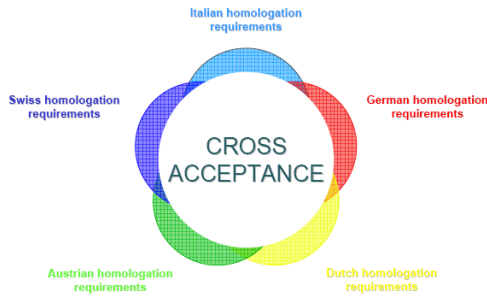

The IRL describes the requirements (standards, regulations, laws and rules), according to which single components up to whole railway-vehicles are officially approved.

In agreement with the TFI members, AEBt compiled in the IRL one common requirement list for railway vehicles (until now Electro- and Diesel-engines) from current requirement catalogues of the TFI-members. The IRL contains all current requirements of the national homologation organisations and network operators.

The requirement list is displayed in your browser as a website which allows the access to the data-base.

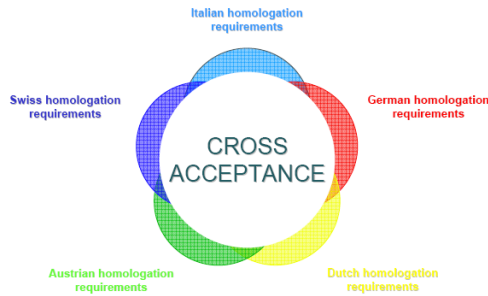
The access to the website of the IRL is provided via an authentication system. The communication with the data base is secured through an encrypted SSL connection.

The requirement list is displayed as a spread-sheet table. The layout and properties of a requirement are set by a blank form.

There is a search mask for the user. The search function interprets all fields of the form as well as all data records from the data base. The search will be done for the set language only. There are additional filters for found or displayed data sets. By this, you can use the filter for all properties of the form.

You can export the catalogue as a PDF-file. This function is available for the selected data sheet or the whole catalogue.
